## TOUR ITINERARY

### Monday, June 20:

**5:00 am:** Motorcoach will depart from Lancaster, AC Moore Store located in Lancaster Shopping Center on the Oregon Pike/Route 272 side of the store.

**6:00 am:** Depart from Harrisburg, AAA Central Penn, 2301 Paxton Church Rd; travel to NY with a rest stop en route. Morning arrival at Mohonk Mountain House situated high in the Shawangunk Mountains overlooking a beautiful lake and the mountains of the Rondout Valley. You will enjoy lunch in the grand dining room with a plethora of culinary delights. After lunch you will take a carriage ride on some of the trails to further enjoy the beauty of the resort. This evening check into our hotel, take time to relax and freshen up before we gather for a delicious dinner. Hotel: *Best Western Plus*, Kingston, NY (Lunch, Dinner)

### Tuesday, June 21:

After breakfast, we'll meet our local guide and depart for a day in Hyde Park, the home of Franklin D. Roosevelt, the 32nd President of the United States. This home was purchased by his father in 1867 and was inherited by FDR upon his mother's death. Its interior remains the same as it was during Roosevelt's lifetime. You will have an escorted tour of the home and grounds by one of the park rangers. Following the tour there will be time to enjoy the library and museum at your own pace. After your delightful included luncheon there will be independent time for shopping in this quaint town. This afternoon arrive at the Vanderbilt Mansion and a park ranger will guide you through this 50 room classical-style mansion. Dinner this evening will be at Rhinecliff Hotel, a boutique hotel that is nestled on the banks of the Hudson River. A special treat will be a presentation by a local chocolatier, Oliver Kita, about the journey of creating great chocolate from the families who grow the cocoa beans to the chocolatiers who master its flavor to enchant your personal palette. Enjoy his knowledge and humor as you taste the wines and chocolates selected especially for you. (Breakfast, Lunch, Dinner)

**Wednesday, June 22:**

After breakfast, depart for another day of touring. The first stop will be at the Walkway over the Hudson, the longest pedestrian walkway in the world at 1.28 miles and 212 feet above the Hudson River. Then enjoy the Storm King Art Center, widely celebrated as one of the world's leading sculpture parks located in the lower Hudson Valley. There is a guided tour of the main building and trams are available to take you to the different sites where you can then walk to view the art. Lunch today is at The Thayer Hotel, which is located on the grounds of West Point followed by a guided 90 minute tour of the academy. West Point is the oldest military school and the nation's oldest continuously occupied military post. A stop will be at Trophy Point and Cadet Chapel. The last stop of the day will be at Brotherhood Winery, the oldest winery in America, for a tour of the facility and a tasting of a selection of their finest wines. Dinner tonight will be at a restaurant on the waterfront in Kingston. (Breakfast, Lunch, Dinner)

**Thursday, June 23:**

Check out after breakfast and meet your guide for a day in Kingston. Tour the Stockade area, which was burned by the British, and features the Senate House and Senate House Museum, the Old Dutch Church and the Persen House. Following the tour we will board the "Rip Van Winkle" for a delightful two hour cruise while enjoying our box lunch before our journey home. (Breakfast, Box Lunch)
