MOTORCOACH ITINERARY

From the time of William Penn through the turn of the 20th century, many of Philadelphia's finest families built their country estates on the banks of the Delaware River. By river barge or carriage they came to escape the heat of summer in the city and it was here that they entertained some of the foremost figures in the history of our nation. **Andalusia** is privately owned by the seventh generation of the Biddle family, one of Philadelphia's first families. Andalusia is perhaps the finest example of Greek revival domestic architecture in the United States and reflects the elegance of 19th century life. **Glen Foerd on the Delaware** has the distinction of being listed on the National Register of Historic Places, was build circa 1853 by Charles Macalester, founder of the village of Torresdale, a financier, and advisor to eight U.S. Presidents. Enjoy a delightful three course lunch at the **King George II Inn**.

Then visit **Pennsbury Manor** which was originally built in 1683 and was the country estate of William Penn, founder and first governor of Pennsylvania. Tour his elegantly reconstructed Manor House furnished with one of the finest collections of 17th century furniture in America.

Arrive at **Byers' Choice® Ltd.** where you can take a stroll down a life sized London Street scene, view where the carolers are brought to life from the observation deck, and shop in a German market.
